Welcome to Pennsylvania Access To Criminal History

The PATCH unit will no longer mail out any PATCH check that is requested on the EPATCH web site. It will be the responsibility of the requestor to ensure that the PATCH check is properly submitted by mail.

All requests for Notarized copies of a Criminal Record Check MUST BE submitted by mail.

Request Under Review: If this status is assigned to the request, the user must periodically check the PATCH web site to determine the final status of the request.

- No Record:** Follow the instructions above for a no record response.
- Record:** Indicates the person has a record and it is the user's responsibility to double click on the control number. This will take the user to the "Certification Form", near the center of the page. By clicking on "Certification Form", a certified record form and the corresponding Record Check will be printed.

ending: This status is occasionally assigned when traffic is extremely heavy and requires the user to check back at a later time. A request should not be submitted for more than 24 hours call the PATCH Help Line toll-free at 1-888-QUERY-PA (1-888-783-7972).

All history responses requiring notarization can only be notarized by a Pennsylvania State Police notary. The notary seal is considered valid at the time of issuance. If the notary's commission expires, please contact the Secretary of the Commonwealth via mail at 210 North Office Building, Harrisburg, PA 17120 or by telephone at (717) 787-5280.

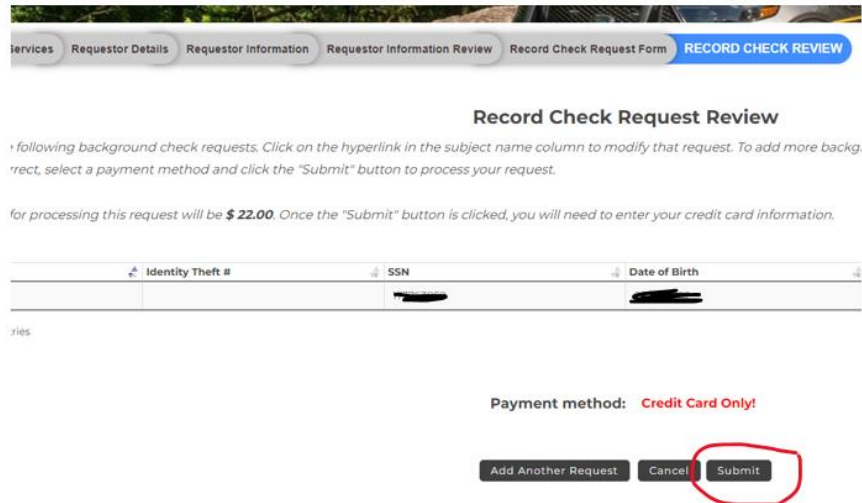
Public reappointment occurs 2 to 3 months prior to expiration of their commission. If the expiration of the notary's commission interferes with the process, it is necessary for you to submit a new request for criminal history record check.

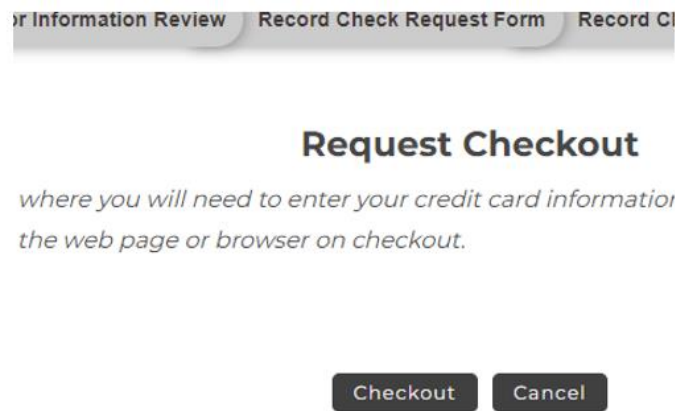
